```
SQL> SELECT tablespace_name, autoextensible, bytes/1024/1024 "SIZE"
       FROM dba_data_files WHERE tablespace_name LIKE 'UNDO%';
```

TABLESPACE_NAME	AUTOEXTENSIBLE	SIZE
UNDOTBS1	YES	70
UNDOTBS2	NO	2

USER1 executes DML, which generates more than 2 MB of UNDO.
